



## Shenzhen 5 Data Center Enters Service Ahead of Schedule

### - A Leading Cloud and Internet Company Commences Operations at the Facility -

Strategically located in the northern part of Shenzhen, SZ5 has a total IT capacity of 10,000 sqm and is one of the largest edge data center facilities in China. The Company acquired SZ5 while it was still under construction in March 2017. Phase 1 of SZ5, comprising 5,000 sqm of IT capacity, is 100% committed by one of the leading cloud and internet companies in China. This customer has commenced operations at the facility.

"We are very pleased to have brought Phase 1 of SZ5 into service a full quarter ahead of schedule, thus enabling one of China's leading cloud and internet companies to accelerate its deployment at the facility," stated Mr. William Huang, Chairman and Chief Executive Officer of GDS Holdings. "It is rare to find a data center like SZ5 with its substantial size, power capacity and strategic location. It is ideal for today's hyper-scale advanced customers and a valuable addition to our portfolio of high-performance data centers in the Tier 1 market of Shenzhen. We also have strong demand in hand for Phase 2 of the facility."
